Effective April 22, 2014

1. Records Requests: Incident reports, fire investigation reports, miscellaneous copies of public records in accordance with Colorado Revised Statute Title 24, Article 72, Section 205 (1) or The Fraudulent Claims and Arson Information Act. Colorado Revised Statute §10-4-1001 shall be assessed a fee of \$20 for the first 10 pages and \$.25 per page thereafter. Copies of CD's of any photos, which have been authorized for release, will be assessed a fee of \$25 per CD. Construction plan documents (blueprints) shall be assessed a fee of \$5 per page if greater than 11" X 17". A fee of \$20/hour may be assessed for location and retrieval of large volumes of documents.
